We have obtained a ruling from BAWA regarding the use of substitutes in pairs' competitions. If you know you cannot attend one of the sessions you may nominate a substitute and this is acceptable providing, in the opinion of the director, the substitute is not significantly better than the player they are substituting.

Next year the evening competitions will be held on a Thursday with the exception of the Open Pairs which will be on the Wednesday. This avoids conflict with BAWA events and so will enable more members to attend. Thanks go to Bente who organised the schedule.

We are also introducing a new competition for beginners and novices. There will be a handicap team event. Pairs will enter and the top seeds will pair with the bottom seeds and so on. What would you lead?

The bidding is

North	East	South	West
-----	1NT	2H	Pass
Pass	Pass		

You (West) hold

S Q86    H 85    D K742    C K963

Answer

Lead the 5H. Your side has considerable HCP in view of partner's 1NT opening, so cut down the enemy's most likely source of winners-ruffs.

### Bridge Teasers

You are in a suit contract and West leads the 3. What card do you play?

	North	
	7 6 4	
3 led		J played
	South	
	K Q 5	

The King is the card to create ambiguity for West. Placing their partner with the Queen West may again lead away from the Ace when they regain the lead (of course they should not have under led the Ace!)

The same problem but different cards

North  
J 10 4

3 led

5 played

South  
A Q 9

In the above, put up the jack from dummy as though trying to induce a cover and so overtake smoothly with the Queen when East plays low. When next on lead West may continue the attack expecting your ace to fall. That way you make 3 tricks with the King with West!
