Bridge is easy for the experts

A few Thursdays ago I was north and held the following hand

57 **H** A J 10 5 4 3 **D** 8 6 4 3 **C** 9 7

West opened 1NT and east raised to 3NT.

I had to lead. Beginners are taught to lead the fourth highest unless............. This is one of the exceptions. From a holding of A J $10 \times x$ you lead the J. If the opponents win then when partner gains the lead they return a heart and if west only has three hearts they are gone. The actual hand was as follows

N **▲** 7 ♦ 8643 *****97 W E ▲ KJ632 ♠ 9 5 ▼ K 9 2 ♥ Q 6 ♦ K Q 2 ♦ A J 10 5 **♣** K 6 * A Q 8 5 3 S *A* A Q 10 8 4 **♥** 8 7 ♦ 9 7 *J 10 4 2

You can see what happens if you lead the fourth highest. Declarer makes the contract easily. West played the Q on the J and the rest is history. Could it have been played differently? - see next issue for the answer. Well this is the next issue and so here it is.

The answer is yes. Had Gerry Daly been playing it (and yes I sought his advice) he would have ducked the first round. Unless the clubs break 3:3 (and you should expect a 4:2 break) you must lose the lead and the only hope of making the contract is for a 6:2 break in hearts with South gaining the lead but then unable to lead a heart back to partner. Holding up is therefore the best way to play the hand. If the clubs break all is well but if not you still have a chance. Take the first round of hearts and it is all or nothing.
