## FROM THE DIRECTORS TABLE

## **IS IT ALRIGHT TO CHANGE YOUR CALL?**

Well we are talking bridge here, not just an everyday part of life's rich pattern, and the answer is a qualified 'yes'.

This problem most often comes up in the bidding process. Partner bids 1C and you pull out 1S and put it on the table. Immediately you are horrified and think to yourself, I've pulled out the wrong bidding card, I meant 1NT. If you have fingers like pork sausages, or even if you haven't, it's so easily done.

You have now made an Unintended Call, so what can you do about it? Well the relevant law says you may substitute an unintended call for an intended call but only if you do so, or attempt to do so, without pause for thought.

So it's nothing to do with how fast you try to make the change (in fact, you have until your partner makes his or her bid to try to make the change)....it's all about the concept, that it was absolutely and unequivocally something you didn't mean to do in the first place.

So what do you do now? Well the safest thing is to throw yourself on the mercy of your opponents, look them in the eyes and say "I've bid something that I didn't mean to bid". At club level, the vast majority of such opponents will see your dilemma and say "Go ahead and change it" unless they have reason to think that you've had second thoughts and your first bid wasn't a wrong one but simply one that, on reflection, is not as good as the second one. Do you see my drift?

If your request is refused, or if your opponents believe you are now giving too much information to your partner, your friendly and helpful Director should be called. He or she will ask a couple of questions about the way the problem occurred and will probably look at the "offender's" (a strong way to describe you, but this is war) hand. If the view is taken that, by the appearance of the hand, there can be no question that the first bid was way up the creek without a paddle, your change will, in all likelihood, be allowed. If there is doubt, it will be ruled that the original call must stand, and as Partner is now aware something funny is going on, the Director will tell your opponents to call him or her back at the end of the hand if they think they have been disadvantaged.

So you see it is not a hanging offence, and in all probability you will be allowed to put things right. The Director will know that it is probably in the best interests of everyone at the table to do so, or some remarkably strange bidding then ensues.

While on the subject, can I just mention darn bidding boxes. Please don't fish around in them and half or even fully pull a bid out and then put it back again. The Regulations say that a bid is considered to be made if it is held face up, touching or nearly touching the table, **or maintained in such a position as to indicate that it has been made.** 

The last phrase causes a lot of dissent. What position so indicates? Well if the bidding card has been seen by others at the table, it must be assumed that offender's partner has seen it. No matter what you do after that, partner will know that you are thinking of bidding 3H, if that is the bid you are fiddling with. If you put the bid back and then pass, that makes things even worse. So, again, the safest thing to do is for the opponents to call the Director. If he or she doesn't agree that the card has been maintained in such a position, it will still be clear that unauthorised information has been passed to partner, who must go out of his or her way not to make use of it. If it is ruled that it has been held in such position, that bid will have to be laid down. If it is ruled that it is unauthorised information that may subsequently damage the non-offenders, it is still probably in your interest to lay that 'fiddled with' bid down and no subsequent damage is done, except to your ego!

Hope that helps.


## **PERSONAL NOTES**

## **A HAND TO PONDER UPON**

## A VERY WILD HAND

Playing with Denise Borger, I sat East on the following hand. What a monster! 12 high card points and a 7/6 distribution in the red suits. What to open? If North/South compete in the black suits and East/West have a fit in one of the red suits, the prospects of being doubled in any contract at up to the 5 level was, to say the least, salivating.



At our table the bidding went:

East	South	West	North
1 heart	1 spade*	2 clubs**	2 spades
4 diamonds	4 spades	5 diamonds	all pass

<sup>\*</sup> Was my hope of a red suit doubled going to come true?

South lead spade king, taken by West's ace and I discarded one of those pesky hearts. I then played the heart 3 won by North's ace. North then played the club ace, which I was able to ruff. I then played a small heart and ruffed it in dummy. The club king was cashed, discarding another of those pesky hearts. The diamond 10 was played from dummy to South's king. That was the end of the defence. Here is a summary of the Board Results:

#### **JOAN ANDREWS**



Joan was born in her Grandmother's house at Cockermouth , Cumberland, England on  $23^{\rm rd}$  December 1924 but adamantly claims she was 'made' in Australia! Joan's Mother was Australian and her Father English and her sister Faye was three years older than her.

Joan, her sister and her parents, remained in England for 12 months and then returned to Australia, living in Nedlands where her father had a Building Company. Dudley, who had a great love of horses, had a sheep station at Roebourne, Wittenoom, where the two of them lived and where their two children, Shelley born in 1955 and Alan born in 1958, were brought up. The family remained on the Station for twelve to fifteen years and had to sell due to Dudley's ill health. They then moved to Kalamunda and Dudley, who was now semi-retired, went to work at Elder Smith & Company, in Midland. Joan developed a love for bridge in the 1970's and often played with Margaret Ferguson, Gerda Toft and Joan Four all members of Kalamunda Bridge Club.

When Dudley sadly passed away, the complex, Villa Maria, where Joan now lives, was in the process of building. Joan approached Sister Joan Flynn, whom she remembers so well, to see if she could buy one of the units and for the princely sum of \$89 000 with a deposit of \$100, Joan became the proud owner of a brand new unit and moved in December 1991 and has been in the same Unit until today. Daughter Shelley and family live in Maida Vale and son Alan and family live in Moora.

Joan has played at Kalamunda Bridge Club for more than forty years and today she plays a 'mean' game and is still as competitive as she ever was.
