## DIRECTORS CORNER

### INSUFFICIENT BID OPTIONS

#### YOU ARE NEXT IN LINE AFTER AN INSUFFICIENT BID - WHAT ARE YOUR OPTIONS?

A round of bidding is going just fine and then suddenly the player immediately before you bids insufficiently. This isn't something that can be fixed without the help of a Director, who must be called straightaway. If the bidder who made the error tries to amend the bid (usually by bidding the same suit but at a higher level) without the Director present, don't allow it.

There is a good reason for this. You, as the next in line, can accept that insufficient bid as it may well be to your advantage to do so, but when, as a director, I offer that facility, many players don't know what to do for the best.

Let's look at a situation where your partner opens 1H, and the next player bids 1D.

The Director is called. Now you know that your partner has somewhere between 11 and 19 points and 5+ hearts in Standard or 4+ hearts in ACOL. You are sitting there with only 4 points and 3 hearts, a hand that is not really strong enough to respond with (particularly in ACOL), and if there had been no intervening bid, you wouldn't have done so. The correct 2D bid from opponent would also have pushed you out of the bidding and if you don't take up my offer of accepting the underbid, and I allow the offender to make a legal bid, that is what will happen. But if you accept the bid, you can then bid 1H even though it's the same bid as opener's. That will tell your partner that you quite like hearts but are not strong enough to bid 2H, a valuable piece of information.

That is a very simple example of the principle. Taking advantage of an insufficient bid becomes a lot more exciting when it happens at a higher level in the bidding. If there is a 4H bid over your partner's 4S it may be better to accept and then bid 4S rather than your opponent being given the option of bidding 5H and pushing you to 5S.

So, in these circumstances:

- (a) always call the Director; and
- (b) think carefully about possibly allowing the underbid.

## MEMBER PROFILE

### DAVID CHARTERS

Betty and I considered it was a great honour to have a person in the club such as David Charters because he was part of a number of people instrumental in the beginnings of our club. We wanted to interview and know more about this great (modest) bridge player responsible for what we in Kalamunda enjoy today. Betty and I are both relative 'new comers' to the club and so learning of some of the past about the club is most important to us! David does have his memoirs written and it would be with great deference the bridge club tries to get a copy of this, along with the fact that David is, of course, a long time exceptional player.



#### An Abridged version of David's Life:

David was born 1931 in Tunbridge Wells, UK. His family moved to Kenya in 1932 where he had his first birthday, and was brought up there with his brother John. His father was a Doctor to a Mission Society. He had quite an extraordinary family. His Great Grandfather was a Vicar. His Grandfather, a School Teacher. His father a Doctor and mother a Nurse, and he himself a Lawyer. He did most of his schooling in South Africa and ended up in Cambridge University in the UK, much the same as his predecessors and his brother. The boys learned to play Culbertson bridge with their parents during their holiday breaks from school with David later learning to play Acol with his wife and now American Standard with his daughter Joscelyn. David graduated Law and was called to the bar at Gray's Inn in London. After 1 year of practising there he was called to do National Service in Kenya, which he did with the Mounted Section. It was only for 6 months but they learned how to ride and shoot and look after horses, all taught by themselves, as their unit was an irregular unit operating in the southern part of Kenya. They took their horses to areas they thought would be most useful. He enjoyed this period with the horses riding through the beautiful Kenyan savannah and forests with all the wonderful wild animals around. At this time they would play bridge in the evenings when they could. David's commander was a keen polo player, and if they were near a polo field he insisted they play polo. Another of his many skills!

After National Service, David joined the Attorney-General's Chambers in Nairobi, where he prosecuted terrorists. Here he met his lovely wife Claudine who was a highly regarded secretary in the Colonial Service, and was also quite an accomplished polo player. Their free time was spent playing polo and going on safaris. They did, however, occupy their evenings with playing bridge. They married in 1958, and unfortunately Claudine missed making their 60<sup>th</sup> wedding anniversary by 12 days. They had a magnificent life together travelling all over the world and having two wonderful children in Joscelyn and Rod. After independence, they decided to come to Perth, Australia, in 1964, when Joselyn and Rod were just 2 and 3 years old, thereby joining their parents and brother who were already here. In Perth, David was Chair of the Workers Compensation Board and a District Court Judge for 13 years.



Bridge and polo had been a large part of Claudine and David's life and while a group were playing casual bridge, David and Mike Hopper (a great inspiration and driving force), decided a club should be created nearby in Kalamunda, thus the "Kalamunda" Club was created on 30 September 1971. A number of those original club players still play today.

David also had many other interests such as tennis, golf, and squash. How he ever found the time, we don't know! His wife and he were two very active people!

When asked for a particular memory, David recalled that in a 'fairly big' championship, in Melbourne, one of the players played a contract based on the 'No Point System'. Under the rules at the time, you were compelled to give a week's notice to the opposition that you would be playing this system. The opposition appealed the ruling and as a result an appeal panel was set up. The panel overruled the Director's decision after which he immediately left the room, and the competition! David doubts he would have ever acted as a director again in the future.

One event in David's mind is worthy of mention: Many years ago, Claudine and he boarded a crowded bus in New Delhi. David sat in one row with Claudine in another. David sat next to a gentleman who asked if he was from England, and he replied 'no, from Australia'. He responded "I know someone from Australia. I wonder if you know her". David said "there are a lot of people in Australia, but who is she?" He replied "Claire Lester". That was extraordinary, because we knew her extremely well. Her Aunt, Xenia Richards was one of Claudine's closest friends and regular bridge player. This gentleman played bridge for Pakistan and had competed against Claire (who played for Australia) in international events. During the rest of the bus trip I was treated to a discourse of interesting hands he had played. How uncanny was this?

Betty and I were enthralled by David's fantastic life and in asking what his favourite memories were he could only say that they had so many wonderful experiences all over the world he couldn't decide on one being better than another. He did however, recall a most memorable bridge event with Claudine when they were selected to play in the Victor Champion Challenge Cup in Melbourne with Gerard Roussilhes and Sathi Moses making up a team with them. The other part of the team was Peter Smith, Haydn Lowe, Helen Hawkins and Helen Bunning.

He states that Claudine was an accomplished bridge player who struggled hard to improve his game. They had many lovely years playing bridge along with their other activities.

He now plays with his daughter Joscelyn regularly (who he says is teaching him Standard American). He also plays with his son Rod, when he's here visiting from overseas, and his son-in-law Colin (Joscelyn's partner) who has taken a keen interest in the game.

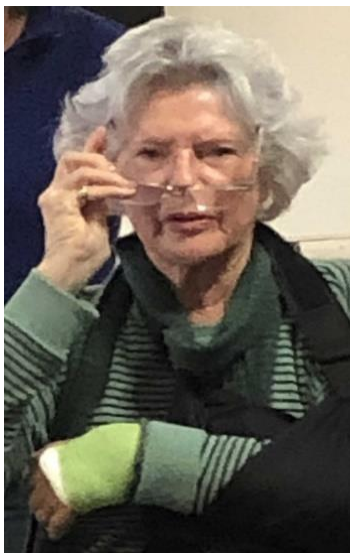
